1) The candidates who have Auto freezed or chooses self freezed their allotment in CAP Round I shall report to the institute as per schedule.

3) No institution, who has in its possession or custody, of any document in the form of certificates or any other documents deposited with it by a person for the purpose of seeking admission in such institution, shall refuse to return such certificates or other document with a view to induce or compel such person to pay any fee or fees in respect of any course or program of study which such person does not intend to pursue or avail any facility in such institution. 4) The institution shall not recover the fees for the subsequent years from the student seeking cancellation of his admission at any point of time before cutoff date of admission cancellation.
