1) The candidates who have Auto freezed or chooses self freezed their allotment in CAP Round II shall report to the institute as per schedule.

2) The Institute shall verify the required documents (original documents as per the photo copies of the required documents verified by Scrutiny Center) and upload the admission of the candidates in the online system through Institute Login immediately within the schedule without fail and shall issue a system generated receipt of confirmation of admission & fee paid receipt to the candidate.
