1) Candidates to whom the first time allotment is made or got betterment in allotment or No betterment (Earlier seat retained) In Round III shall be final. Such a candidate must report to allotted institute for confirmation of admission in given schedule only..

2) The Institute shall verify the required documents (original documents as per the photo copies of the required documents verified by Scrutiny Center) and upload the admission of the candidates in the online system through Institute Login immediately within the schedule without fail and shall issue a system generated receipt of confirmation of admission & fee paid receipt to the candidate.
